

**Community First Fund Credit Union**  
**Member Appreciation Sweepstakes Giveaway Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

- 1. How to Enter** – No purchase necessary to enter or win. Purchase does not improve your odds of winning. The Community First Fund Credit Union Member Appreciation Sweepstakes begins Monday, September 23, 2024 and ends Friday, September 27, 2024 at 6:00pm EST. To enter, members who visit the credit union branch between Monday, September 23, 2024 and Friday, September 27, 2024 during post business hours may submit 1 entry card per day. Members who refer an eligible member may complete an additional entry. There is no limit to referrals. All entries must be received by Friday, September 27, 2024 at 6:00pm EST. You may not enter more times than indicated. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Community First Fund Credit Union.
- 2. Rules and Eligibility** – The Contest is being conducted by Community First Fund Credit Union (the “Sponsor”). Participation in the Contest is limited to individuals who are official members of Community First Fund Credit Union and account must be in good standing. Void where prohibited or restricted by law. If the winner of the Contest prize is a minor in his or her jurisdiction of residence, the prize may be awarded in the name of his or her parents or legal guardian (if allowed by applicable law) or the contestant may be disqualified, in the sole and absolute discretion of the Sponsor. Subject to all applicable federal, state, and local laws and regulations. All eligible entries will be included.
- 3. Drawing Dates** – Drawing will take place on Monday, September 30, 2024 after 12:00pm EST.
- 4. Persons Eligible to Win** – Participation in the Community First Fund Credit Union Member Appreciation Sweepstakes is for Community First Fund Credit Union members. Staff members and their immediate households (including parents, children, stepchildren, spouses, significant others, sibling, and those residing at the same address) are not eligible to participate or win a prize.
- 5. Winners** – There will be two (2) winners chosen by random drawing. A member is only allowed to win one prize. Once one member from a household wins, other members of the same household are not eligible to win. Winners will be notified by phone or email within 2 business days of the drawing and must claim their prize within five (5) business days of notification. If the winner does not respond within seven (7) business days, a new winner will be chose in another random drawing.

Community First Fund Credit Union will have no liability for winner’s failure to receive notices due to winner’s spam, junk email or other security settings for winner’s provision of or otherwise nonfunctioning contact information.

Acceptance of the prize constitutes permission of Community First Fund Credit Union to use the winner’s name (first and last initial) and image for purposes of advertising and trade, without restriction and without further compensation.

No cash alternative to the prizes will be offered. The prizes are not transferable.
